5. Further cheque payment facility of the party will be stopped.
6. Tax and other statutory levies will be applicable at prevailing rates
7. Payment of charges is not guarantee for services, which is strictly on completion of all Customs and other statutory formalities.
8. Movement of Containers are subject to weight restrictions imposed by Govt., Court & RTO. The above is subject to change without prior notice.
9. Charges for 45' containers will be charged 2.5 times of the per TEUs rates.
10. Hazardous cargo declaration with all details may please be provided for safe handling, stacking and segregation norms compliances. CFS reserves the right for allowing or rejecting specific Hazardous commodities in the premises.
11. Crane if required will be charged on case to case basis
12. Any activity not mentioned in tariff will be charged on case to case basis
13. It is presumed that all consignments (Import/Export) being received at CFS are adequately insured against all possible risk during transportation & Storage and Indev Logistics assumes no liability in this respect.
